Intraday Value: An ETF's intraday value (also abbreviated as IOPV or IIV).

Closing price (last trade): The final price of a security at which a trade was made on the stock exchange.

Discount: The amount the Pacer ETF is trading below the reported NAV.

Premium: The amount the Pacer ETF is trading above the reported NAV.
