

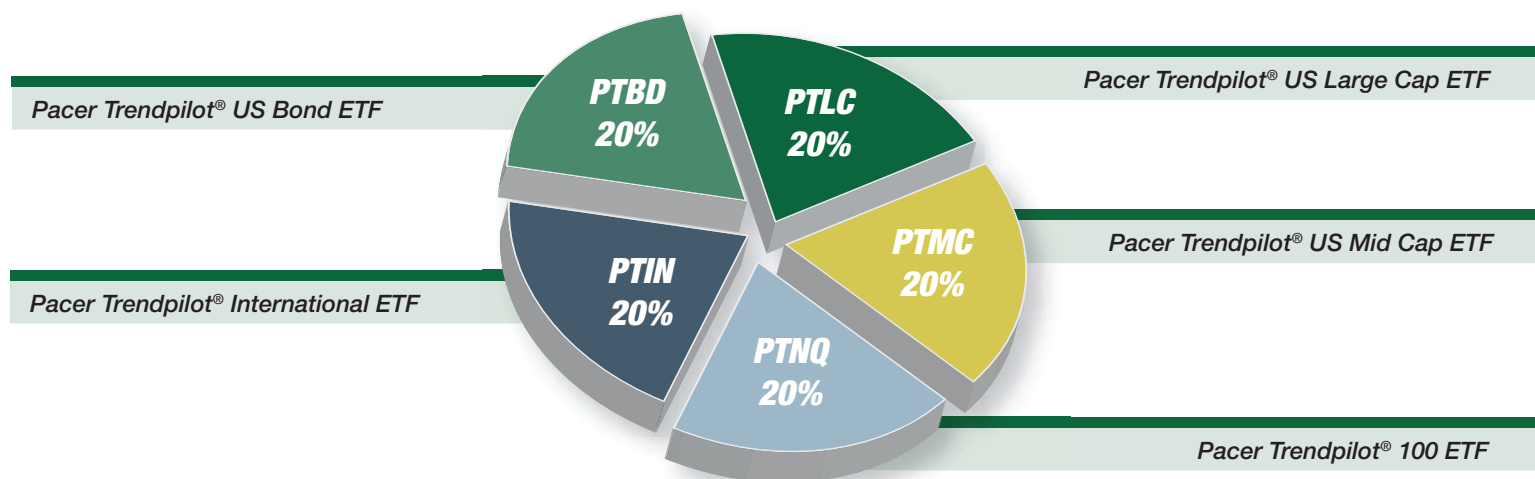

Pacer Trendpilot® Fund of Funds ETF

An index-based exchange traded fund (ETF) that is composed of Pacer Trendpilot® ETFs. Each of the Pacer Trendpilot® ETFs is an index-based ETF that seeks to track the total return performance, before fees and expenses, of the underlying Trendpilot® Index.

This is when NAV is determined for most ETFs. If shares trade at another time, the return may differ. Market and NAV returns assume that dividends and capital gain distributions have been reinvested in the Fund at Market Price and NAV, respectively.

The S&P 1200 Index captures approximately 70% coverage of global market capitalization.
