<u>Market Price</u>: Price at which an investor can buy or sell an ETF during the trading day.
<u>Intraday Value</u>: An ETF's intraday value (also abbreviated as IOPV or IIV).
<u>Closing price (last trade)</u>: The final price of a security at which a trade was made on the stock exchange.
<u>Discount</u>: The amount the Pacer ETF is trading below the reported NAV.
<u>Premium</u>: The amount the Pacer ETF is trading above the reported NAV.
