## Pacer Industrial Real Estate ETF

A strategy-driven exchange traded fund (ETF) that aims to offer investors exposure to global developed market companies that generate a significant amount of their revenue from real estate operations in the industrial sector.

### STRATEGY OVERVIEW

An objective, rules-based strategy that seeks to track the Solactive GPR Industrial Real Estate Index and invest in industrial REITs that are part of the ecommerce distribution and logistics networks along with self-storage facilities.

The GPR 250 Index is composed of the 250 most liquid listed property securities in the world.

#### Sector Screen – Industrial Real Estate Sector

The Index is generally composed of the equity securities of developed markets companies that derive at least 85% of their earnings or revenues from real estate operations in the industrial real estate and self-storage real estate operations.

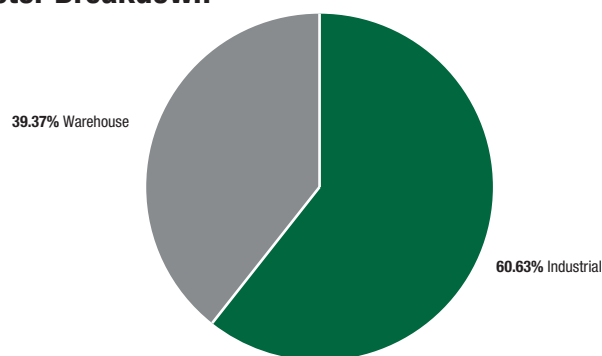

\*\*ETF implied liquidity is a representation of how many shares can potentially be traded daily in an ETF as portrayed by the creation unit. This is defined as the smallest value of the IDTS (Implied Daily Tradable Shares) for each holding in the creation unit.

**NAV** (net asset value) is the value of one share of the Fund calculated daily. The NAV return is based on the NAV of the Fund. It may not reflect the actual return for the investor.

**Market Price** is the price investors can buy and sell ETF shares for in the stock market and is used to calculate market return. It is based on the price at the listed exchange market close. This is when NAV is determined for most ETFs. If shares trade at another time, the return may differ. Market and NAV returns assume that dividends and capital gain distributions have been reinvested in the Fund at Market Price and NAV, respectively.
